I have just completed the Combined District Karting Clubs association audit of financial transactions with new external auditor Benjamin Jenkins from GPP Audit. The financial statements show that we have a strong financial position and are able to meet all current financial liabilities.

The financial statements report a net profit of only \$6,503. However that includes depreciation of the significant investment of last year's track upgrade. The cash profit excluding depreciation is actually \$35,000. The items that have contributed to the profit include track hire, of which we hired the track out 4 times during 2017-18 with a net profit of \$8,000. The canteen also made an annual profit of \$5,000 and race meetings area made a profit of about \$26,000 for the year, with a lot of that amount generated from practice fees.

The bank account balance has increased over the year from \$40,000 to \$69,368 however during the year the balance was averaging \$50,000
